**RESOLUTION FOR ADDITIONAL LIBRARY MILLAGE**

**RESOLUTION NO. 201907-002**

At a special meeting of the Library Board for the Garden City Public Library, Wayne County, Michigan, held at the Garden City Public Library, 31735 Maplewood St., Garden City, Michigan on the 9th day of July 2019, at 7:00 p.m.

WHEREAS, in 2011 the voters of the City of Garden City approved 1.0 mill for the sole and exclusive purpose of providing for the operation and equipment of the City of Garden City Public Library under Section 10a of the City, Village and Township Libraries Act, Act 164 of the Public Acts of 1877 ("Act 164"), MCL 397.201, et seq for the period of 2012 through 2021, inclusive; and

WHEREAS, that millage was subsequently renewed through 2031 inclusive; and

WHEREAS, on July 9, 2019, the Library Board resolved that an additional library millage for a period of ten (10) years is necessary for the design and construction of a new library building to house the Garden City Public Library under Act 164, MCL 397.210c, et seq; and

WHEREAS, upon the governing board of the library determining by resolution that a millage should be sought, Section 10c of Act 164, MCL 397.210c states that the question of whether to approve the millage shall be placed on the ballot for approval at the next regular election; and

WHEREAS, Public Act 248 of 1999, effective March 10, 2000, MCL 211.24f requires that any ballot for a millage also indicate an estimate of the revenue the City shall collect in the first calendar year of the millage if approved by the electorate;

NOW, THEREFORE, be it resolved that:

1. The ballot language to be submitted to a vote of the qualified electors of the City of Garden City, County of Wayne, Michigan, at a regular election to be held on the 5th day of November 2019, shall be:

ADDITIONAL LIBRARY MILLAGE PROPOSAL

*This proposal will allow the City to levy an additional mill to fund the design and construction of a new building to house the Garden City Public Library. The funds collected shall be placed in the Library Fund to be reserved and invested until sufficient to begin design and construction.*

Shall the tax limitation on all taxable real and tangible personal property in the City of Garden City, Wayne County, Michigan, be increased by an amount not to exceed 1.0 mill (\$1.00 per thousand dollars of taxable value) for a period of ten (10) years, 2020 to 2029, inclusive, as new additional millage for the purpose of providing funds for the design and construction of a new library building for the Garden City Public Library and for all other library purposes authorized by law?

It is estimated that 1.0 mill would raise approximately \$527,714.00 when first levied in 2020.

2. A certified copy of this Resolution shall be received and retained by the City Clerk in the manner prescribed by the revised Michigan Election Law.

3. All resolutions and parts of resolutions, insofar as they conflict with the provisions of this Resolution, are hereby repealed.


