Zack Witt asked when the Board received their meeting packets, and the law which requires the City to hold the Library Funds.

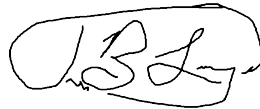
John Murray asked about how the City collected Library funds, ADA compliance of the restrooms, and clarification on the uncashed checks from the City.
